2. Signs and Markers

The identification was checked for completeness at entrance into the mining permit area. The inspector found that the identification sign contained the name, address, phone number and Utah Mining Permit number as required by statute listed in the Utah Coal Mining regulations. The sign is in compliance with the law.

3. Topsoil

New construction is taking place at the Lila Canyon mine. This construction consists of topsoil removal and storage. Earth work to build a compacted pad in which to construct a new warehouse/shop area. These areas of construction were observed during the partial inspection.

4.a Hydrologic Balance: Diversions

The culvert inlet located between the existing storage pad and the topsoil storage area has two large boulders placed over the entrance into the inlet. These boulders need to be removed or placed in manner to leave the inlet unobstructed. Karin Madsen made note of the needed work and contacted surface personnel to perform the work. In addition the road diversion along side of the main access road leading to the mine sites main parking area has several lengths of fusible pipe laying in the reaches of the diversion. These lengths of pipe need to be removed the diversion.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The smaller sediment pond contained a minimal amount of water. Several sediment deltas exist inside of the pond near access points of culvert inlets where the sediment drop out rapidly.

5. Explosives

The magazines for powder and cap storage are located along side of the main access road leading to the portal area. These magazines have a sign posted indicating the storage of explosives. The magazines also have a grounding wire for preventing ignition due to a lightning storm. The storage area and facilities meet the requirements listed in the Federal code of regulations.

7. Coal Mine Waste, Refuse Piles, Impoundments

There is currently no refuse pile associated with this mine site.
