1. There are no pending amendments with the Division at this time.

2. Signs and Markers

The identification sign was inspected and it meets the requirements of the R645 Coal Rules. See Photo

3. Topsoil

I inspected the topsoil piles and I did not see any signs of wind or water erosion. The topsoil piles appear to be stable and protected by a berm.

4.a Hydrologic Balance: Diversions

The permittee has been clean out diversion and culverts of sediment, since the last inspection and rainstorm. Diversion and culverts are open and would function during a storm event.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

Sediment ponds were dry or almost dry. I inspected inlets and outlets and they were open. Embankments were stable since they are incised. No hazardous conditions were noticed. There are six (6) sediment ponds, A thru F.

4.d Hydrologic Balance: Water Monitoring

The permittee had taken second quarter sediment pond inspection. All locations were dry.

7. Coal Mine Waste, Refuse Piles, Impoundments

I inspected the refuse pile. It appears to be stable with no hazardous conditions noticed. Embankment are stable. Diversions around the refuse pile is stable and open.

8. Noncoal Waste

There is some non-coal waste material such as wood, paper and plastic cans lying around the property.

10. Slides and Other Damage

No slides or other damage was notice during the inspection. The Loadout appears to be stable.

16.a Roads: Construction, Maintenance, Surfacing

The roads were compacted with no dust control problem. Roads are seldom used.
