1. PERMIT -

The Banning Loadout out has been bought by ARCO and therefore chapter 1 in the MRP will need to be updated. The identifications signs may need to be updated.

4A. DIVERSIONS -

The diversions were inspected and were found to be functioning as designed. The berm next to the entrance gate needs cleaned up of fines. The operator has committed to clean-up these coal fines.

4B. SEDIMENT POND -

The sediment pond was not discharging during the inspection. The pond contained a small amount of water but will not likely discharge this year.

19. AVS -

The Division will have to do an AVS check before the permit transfer can be approved.
