15. Cessation of Operations

The site is still idle as far as I can determine. The main gate was locked, but the gate to the back entrance was not locked. There is another gate near the substation that was also not locked. The main control building was locked, but the building at the loadout was open.

On July 10, 1996, I spoke with Dave Spillman about whether the company should consider the site to be in temporary cessation. He told me that Soldier Creek has now started to haul coal to Banning and that they will soon be shipping coal. He told me he doesn't know a day in advance whether Banning will be operating or shut down.


20. Air Quality Permit
