
7. Coal Mine Waste/Refuse Piles/Impoundments

The apparent coal refuse that was in the truck loop at the last inspection is no longer evident. Mr. Fredricks said the operator had difficulty finding enough coal for a shipment and probably included the refuse. (Although it appeared to be refuse, there were large pieces of what appeared to be coal. I don't know if it would actually be classified as "refuse.")
