

Mergers Recognized  
Bond Riders and Replacement Bonds Accepted

Acceptable evidence has been filed in this office concerning the following mergers: Soldier Creek Coal Company into Sage Point Coal Company; Coastal Development Company, Sage Point Coal Company, Skyline Coal Company, Southern Utah Fuel Company, and Utah Fuel Company into Coastal States Energy Company; and finally, Coastal States Energy Company into Canyon Fuel Company, LLC with Canyon Fuel Company, LLC being the surviving entity.

For our purposes, the mergers are recognized effective December 20, 1996 (Secretary of State's approval date).

The coal lease files identified on the enclosed Exhibit A have been noted as to the mergers. We are notifying the Minerals Management Service and all applicable Bureau of Land Management offices of the change by a copy of this notice.

The bonds affected by the merger have had riders submitted or entirely new bonds submitted in order to change the name of the principal on the affected bonds.
