**1. PERMIT -**

The permit transfer from Coastal States Energy to Arco has taken place.

**2. SIGNS AND MARKERS -**

The new permittee has ordered identification signs for the Banning property.

**4A. DIVERSIONS -**

The diversions were covered with snow. There were not signs of melting snow within the diversions or within the permit area. The berm near the fence and railroad tracks is going to be surveyed after the snow melts. It appears that the water may not go into the sediment pond as designed. It maybe an illusion due to snow levels and the grading of snow in this area.


**4B. SEDIMENT POND -**

The sediment pond was not discharging during the inspection. The pond did contain a small amount of water. It was impossible to see any kind of erosion due to snow cover.
