1. PERMIT -

The permittee currently does not have any amendments for review at the PFO or SLO.

4a. DIVERSIONS -

The diversions were covered with snow. There was not water flowing within the ditches. These ditches were spot-checked.

4b. SEDIMENT PONDS -

The sediment pond did contain a small amount of water. It is highly unlikely to discharge from the spillway. This pond has never discharged.

4c. OTHER SEDIMENT CONTROL AREAS -

Silt fences are used as alternate sediment control areas. These areas were functioning as designed.
