2. Signs and Markers

Mine ID signs are placed at accesses from the public into the permit area. The signs contain the permittee name, address, permit number, and phone number.

4.a Hydrologic Balance: Diversions

The diversions are snow covered but the snow is melting.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The sediment pond contained snow with little to no water within it. The sediment pond was inspected for the fourth quarter of 2007. No hazardous conditions were reported.

4.e Hydrologic Balance: Effluent Limitations

The sediment pond did not discharge for the fourth quarter of 2007. No UPDES samples were taken.

8. Noncoal Waste

The site was covered with snow. There is old mine materials at the site.

15. Cessation of Operations

The site is inactive.

18. Support Facilities, Utility Installations

No new facilities have been constructed since the last inspection.

21. Bonding and Insurance

The insurance accord form was inspected and complied with the R645 Coal Rules. The policy number is HDO623732920. The policy will expire on July 31, 2008. The bonding amount is \$350,000.
