**4.e Hydrologic Balance: Effluent Limitations**

There was no discharge from the sediment ponds for second and third quarter. Water quality inspected the sediment pond at Banning. There were no issues with the sediment pond.

**8. Noncoal Waste**

The site has mine hardware on the pad area. Some of the equipment may not be in the condition for use.

**15. Cessation of Operations**

The loadout is not being used except as a storage facilities.

**16.b Roads: Drainage Controls**

The road drainage is functioning as designed.
