1. Permits, Change, Transfer, Renewal, Sale

There are no current permitting actions pending. The Permittee needs to submit a permit renewal application for the Banning Loadout by June 24, 2013.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The surface facilities pond contains a large amount of vegetation which should be removed. Although the pond is incised, there are two reasons the vegetation should be removed; 1) the dry material could be set on fire by lightning, which could spread to a range fire, and 2) the amount of vegetation present prevents an adequate inspection of the pond. The growth is in the pond bottom. There is no known regulation which would require removal of vegetation from sediment pond areas.

4.d Hydrologic Balance: Water Monitoring

There is no visible water volume in the bottom of the sediment pond. A check of the water monitoring data base on 5/7/2013 revealed that no water sample has been collected since 2003, due to the lack of collectible water. UPDES outfall 002 (surface facilities pond) has never discharged. All three data collection points are reported as dry or no flow.

4.e Hydrologic Balance: Effluent Limitations

The Permittee has applied for a UPDES permit renewal from the Utah Division of Water Quality. The status of that application is unknown.
