

Thank you for taking time to meet with representatives from Sunnyside Cogeneration Associates ("SCA") on Friday to discuss the Division Order referenced above. We appreciate your efforts to resolve the issues set forth in the Division Order.

The Division Order requires that SCA make permit changes and submit a revised bond amount by August 1, 1996. SCA did not receive the Division Order until July 9, 1996. As we discussed in our meeting on Friday, the Division Order raises issues which are complex and which require more time to resolve. Accordingly, SCA requests that the Division extend the deadline contained in the Division Order from August 1, 1996 to September 1, 1996.

Please send me written confirmation of the extension of this deadline as soon as possible.
