General Comments. A partial inspection was completed on 12/8/97. The operator had purchased a tractor with implements to perform routine maintenance work. This will provide the operator with greater flexibility on taking care of routine maintenance items. Drainages. Drainages, ditches and culverts were functional even though with the cold weather no thawing is taking place. Snow has not melted from the north facing slopes.

Sediment Ponds. Pasture and the tipple ponds have been cleaned and the material transported to the spoil pile.

Siltfences. The siltfences were cleaned and the material transported to the spoil pile.

Roads. Roads had been graded with a patrol.
