

East Carbon to file action in 7th District

During a regularly scheduled public meeting on Oct. 14, East Carbon Mayor Paul Clark updated council members on the status of the city's ongoing negotiations with Penta Creeks for the purchase of land and Grassy Trails Reservoir.

Clark informed the council about a discussion the mayor recently had with Greg Jensen, one of the owners of Penta Creeks

Clark advised the East Carbon officials that Jensen indicated there were several reasons why the Penta Creeks owners have not signed and returned the purchase agreement.

Jensen identified the main issue as being that the company's owners have been very busy attempting to acquire the footprint property, pointed out Clark.

Clark also informed the council that a mistake had been made in the original agreement sent to Penta Creeks.

The city inadvertently included all water rights involving the range creek property. The city immediately sent a revised copy of the agreement to Penta Creeks.

In addition, the mayor revealed to the city council members that he had discovered that

Penta Creeks was apparently trying to sell the reservoir to the Utah Division of Wildlife Resources.

Clark subsequently informed the DWR that the city would not enter into a conservation easement agreement in the event the division intended to proceed with the reservoir's purchase.

A conservation easement would not allow the cities to drain the reservoir below a certain point, explained the mayor. In the past, Clark pointed out that East Carbon and Sunnyside cities have had to drain the reservoir below normal during drought years.

Addressing the ongoing issue, the council passed a motion to contact East Carbon City's water attorneys and direct the legal representatives to proceed with a declaratory action from a local district judge on the enforceability of the 1951 agreement.

In addition, the East Carbon council members also passed a motion to join with Sunnyside City in a joint condemnation action involving the local water treatment plant area.

Mayor Clark also informed the council of the "Hatfield and McCoy" feud that has been brewing with hunters and pri-

The city discovered that the cities' lock on the reservoir gate have been cut and replaced with another one.

Mayor Clark contacted Penta

Creeks to advise them that if copies of the keys to the lock were not given to the cities, "the whole gate would come down."

The cities received copies of the key to the lock within the time allocated by the mayor.

Bott replied that a council cannot impose any requirements over and above the city's zoning ordinances.
