**2. Signs and Markers**

The mine ID sign is posted at the access to the permit area. The ID sign contains the required information. The operator has placed a sign on top of the Borrow Area Topsoil Pile. The sign was missing during the last inspection. All other signs and markers observed during the inspection were in compliance with the approved MRP.

**3. Topsoil**

The berm around the access road topsoil pile has been redefined. The berm will now provide adequate protection to the topsoil pile. Additional work on berms was performed on other topsoil piles.

**4.d Hydrologic Balance: Water Monitoring**

Third quarter 2003 water monitoring information has been submitted and uploaded into the EDI website. Water monitoring is current.

**7. Coal Mine Waste, Refuse Piles, Impoundments**

The refuse pile was inspected and found to be stable and free of any smokers or visible hazards.
