2. Signs and Markers

The ID sign is in place at the entrance into the permit area. All other signs and markers observed during the inspection met the coal rules.

4.d Hydrologic Balance: Water Monitoring

Third quarter 2003 water monitoring is in the EDI website and uploaded. Water monitoring is current.

7. Coal Mine Waste, Refuse Piles, Impoundments

The pile appeared to be stable. One smoker was observed on the pile during the inspection. The permittee documented the location and contacted operations to have the area extinguished according to the approved method listed in the MRP and MSHA regulations.

8. Noncoal Waste

A haulage trailer was observed on the upper portion of the refuse pile that has had the wheels and axles removed. This item was discussed with the permittee. Operations will be contacted to determine why the trailer is located on the pile and to arrange for the removal of the trailer.
