2. Signs and Markers

The Mine ID sign has been re-established since the last inspection. All other signs and markers observed during the inspection are in compliance with the approved MRP.

4.d Hydrologic Balance: Water Monitoring

The approved permit indicates that baseline water monitoring be done for one quarter every fifth year before permit renewal for all of the monitoring sites. This item was not done prior to the last renewal as identified in the joint inspection with the Division Hydrologist during the last inspection. The operator committed to performing baseline monitoring for all of the sites during the first quarter of 2004. Collection of the baseline samples is scheduled for March 2004. Fourth quarter 2003 water monitoring has been entered and uploaded into the EDI website. Water monitoring is current.

6. Disposal of Excess Spoil, Fills, Benches

Placement of material into excess spoil pile #2 has almost filled the old #1 and #2 slurry cells. Slurry cells #1 and #2 were incised into the ground and excess spoil is being placed inside of the old cells. Excess spoil pile #2 can continue above the natural ground level, but the approved MRP will require modifications to allow further placement. The modifications will need to be approved by the Division and should address how the placement of material will proceed in lifts, proper drainage and designed diversions. During this permitting process, the operator will probably reactivate excess spoil pile #1.

7. Coal Mine Waste, Refuse Piles, Impoundments

The ID sign for the refuse pile was in place and contained the required information. The refuse pile appeared stable with no visible hazards.
