**1. Permits, Change, Transfer, Renewal, Sale**

The mine ID sign is located adjacent to the tipple. The MSHA Refuse and Impoundment signs were also checked during the inspection.

**4.b Hydrologic Balance: Sediment Ponds and Impoundments**

A large rock was observed in the inlet diversion to pond 009. The operator made arrangements to have the rock removed during the inspection.

**4.d Hydrologic Balance: Water Monitoring**

First quarter 2004 water monitoring is in the EDI website and uploaded. Water monitoring is current.

**7. Coal Mine Waste, Refuse Piles, Impoundments**

Material from the refuse pile continues to be removed in lifts. The area appeared stable with no visible hazards.
