The mine ID sign is located adjacent to the tipple on a light pole. The MSHA Refuse and Impoundment signs were also checked during the inspection and contained the required information.

4.d Hydrologic Balance: Water Monitoring

First quarter 2005 water monitoring is in the EDI website and uploaded. Water monitoring is current.

6. Disposal of Excess Spoil, Fills, Benches

Spoil is still being placed in Excess Spoil Pile #2. The permittee has an application submitted to the Division requesting the Expansion of this disposal area, Task ID #2223.

7. Coal Mine Waste, Refuse Piles, Impoundments

The surface of the refuse pile is being mined in benches. A new bench has just been started. The surface of the pile appears stable. No visible hazards were noted during the inspection.

A bond review and adjustment is currently taking place between the Division and the Permittee.
