1. Permits, Change, Transfer, Renewal, Sale

The mine ID sign is located adjacent to the tipple on a light pole. The MSHA Refuse and Impoundment signs were also checked during the inspection and contained the required information.

4.d Hydrologic Balance: Water Monitoring

Third quarter 2005 water monitoring is in the EDI website and uploaded. Water monitoring is current.

6. Disposal of Excess Spoil, Fills, Benches

Excess spoil pile #2 has been idled until the deficiencies on that facility are addressed. Excess spoil pile #1 has been activated and is currently receiving spoil.

7. Coal Mine Waste, Refuse Piles, Impoundments

The refuse pile appears stable. No visible hazards were noted during the inspection.
