1. Permits, Change, Transfer, Renewal, Sale

There are no pending compliance actions. The only permit condition currently in place is that the permittee must submit all water monitoring data in an electronic format to the Division's web site. The permittee is complying with this stipulation.

2. Signs and Markers

The mine ID sign is located adjacent to the tipple on a light pole. The MSHA Refuse and Impoundment signs were also checked during the inspection and contained the required information.

4.a Hydrologic Balance: Diversions

The culvert inlet and outlet by the fuel storage and reclaim area are about half and three quarters full of sediment. The culvert and ditch need to be cleaned. Richard Safley documented the needed maintenance to have it addressed as soon as possible.

4.d Hydrologic Balance: Water Monitoring

Second quarter water monitoring information is in the EDI website, but has not been uploaded. Water monitoring is current.

7. Coal Mine Waste, Refuse Piles, Impoundments

The smokers on the refuse pile identified during the last inspection have been extinguished. No signs of smokers or visible hazards were noted during the inspection.
