1. Permits, Change, Transfer, Renewal, Sale

There are no pending compliance actions. The only permit condition currently in place is that the permittee must submit all water monitoring data in an electronic format to the Division's web site. The permittee is complying with this stipulation.

2. Signs and Markers

The mine ID sign is located adjacent to the tipple on a light pole. The MSHA Refuse and Impoundment signs were also checked during the inspection and contained the required information.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

Sediment ponds 007 and 012 have been cleaned. Sediment pond 009 (Pasture Pond) has been cleaned and expanded. Pond 009 now has the capacity to hold the additional drainage from the Slurry Cell 1&2, Clear Water Pond area. The Slurry Cell 1&2, Clear Water Pond site serves as an excess pile storage area.

4.e Hydrologic Balance: Effluent Limitations

Second Quarter 2007 water monitoring is in the EDI website, but has not been uploaded. Water monitoring is current.

7. Coal Mine Waste, Refuse Piles, Impoundments

Refuse pile is being mined in various lifts and areas depending on quality and plant demands. The refuse pile appeared stable with no visible hazards.
