4.d Hydrologic Balance: Water Monitoring

Second quarter 2007 water monitoring information is in the EDI website, but has not been uploaded. Water monitoring is current.

7. Coal Mine Waste, Refuse Piles, Impoundments

The refuse pile appeared stable with no visible hazards.

16.a Roads: Construction, Maintenance, Surfacing

The roads throughout the area where the refuse is being excavated were watered to prevent dust from leaving the site.
