2. Signs and Markers

The mine ID sign is located adjacent to the tipple on a light pole. The MSHA Refuse Pile sign was also checked during the inspection and contained the required information.

6. Disposal of Excess Spoil, Fills, Benches

The excess spoil pile where the old #1 and #2 slurry cells were located is actively receiving material.

7. Coal Mine Waste, Refuse Piles, Impoundments

Refuse pile appeared stable with no visible hazards. Pile is being mined in lifts according to fuel quality and needs.
