1. Permits, Change, Transfer, Renewal, Sale

The mine ID sign is located adjacent to the tipple on a light pole. The MSHA Refuse Pile sign was also checked during the inspection and contained the required information.

7. Coal Mine Waste, Refuse Piles, Impoundments

The refuse pile is being mined in varied lifts according to coal quality needs. The pile appears stable. No visible hazards.

18. Support Facilities, Utility Installations

Material from the Star Point refuse pile that has been mined and transported to Sunnyside is being stored on a pad area. This material will aid in the power plant fuel supply during bad weather.
