2. Signs and Markers

The mine ID sign is located adjacent to the tipple on a light pole. The MSHA Refuse Pile sign was also checked during the inspection and contained the required information.

6. Disposal of Excess Spoil, Fills, Benches

Excess spoil pile #2 remains active. Material continues to be placed on top of the pile and then compacted in lifts.

7. Coal Mine Waste, Refuse Piles, Impoundments

The refuse pile is being excavated in various lifts depending on the needed quality for the power plant. The refuse pile appeared stable. No visible hazards were observed.
