1. Permits, Change, Transfer, Renewal, Sale

2. Signs and Markers

The mine ID sign is located adjacent to the tipple on a light pole. The MSHA Refuse Pile sign was also checked during the inspection and contained the required information.

6. Disposal of Excess Spoil, Fills, Benches

Excess spoil pile is actively receiving material. The pile is raised above the natural ground level and is being constructed according to the approved design in the mining and reclamation permit.

7. Coal Mine Waste, Refuse Piles, Impoundments

The refuse pile appeared stable with no visible hazards.
