2. Signs and Markers

The mine ID sign is located adjacent to the tibble on a light pole. The MSHA Refuse Pile sign was also checked during the inspection and contained the required information.

6. Disposal of Excess Spoil, Fills, Benches

Excess Spoil Pile #2 was being compacted and regraded during the inspection. Pile appeared stable.

7. Coal Mine Waste, Refuse Piles, Impoundments

Refuse pile is being mined in varied lifts according to fuel quality and power plant needs. The refuse pile appeared stable, no visible hazards observed.

8. Noncoal Waste

The permit area was free of noncoal waste items.
