2. Signs and Markers

Mine identification sign is located on a power pole at the entrance into the permit area. The sign contains the required information.

6. Disposal of Excess Spoil, Fills, Benches

Excess spoil pile #2 is near completion. Final applications are being made to bring the pile to the final capacity. Reclamation is slated to begin this fall.

7. Coal Mine Waste, Refuse Piles, Impoundments

Refuse pile appeared stable. No visible hazards were observed.
