**3. Topsoil**

Topsoil placement will occur next week, after straw and fertilizer are laid down and compaction on cover material is relieved by ripping.

**7. Coal Mine Waste, Refuse Piles, Impoundments**

The cover material has been placed to a depth of 3 ft. on the top of the pile. A road grader and a D6 dozer are working in tandem to cover the north and east sides of the pile. The crew is aware that the north end still needs a little bit more cover at the toe.

**12. Backfilling And Grading**

Three men were running a D6 dozer, D9 dozer and a 631 tractor scraper. The borrow pit has reached its full extent. It is elliptical in shape, approximately 120 feet at its widest end, 200 ft. long and 20 ft. at its deepest. Size of the borrow pit estimated by comparison with dimensions of the equipment.
