3. Topsoil

Topsoil from the designated topsoil pile has been depleted and the borrow area is being excavated. The topsoil is being laid down by excavators. A dozer has pushed the topsoil down to the toeslopes. The topsoil has been pulverized to a fine powder.

7. Coal Mine Waste, Refuse Piles, Impoundments

Contractor is working in one acre segments to apply fertilizer, straw, and topsoil to the subsoil covering the Excess Spoil Pile #2. Approximately half the pile has been treated with the first layer of straw and fertilizer and topsoil. The topsoil cover has not been treated with the final layer of straw and fertilizer or gouged.
