**2. Signs and Markers**

The mine identification sign is securely attached to a power pole at the entrance into the permit area. The sign contains all of the required information.

**4.a Hydrologic Balance: Diversions**

Weeds have been removed from the inlets of the culverts through-out the mine site.

**6. Disposal of Excess Spoil, Fills, Benches**

Excess spoil pile #1 is the active pile at the present time. Excess spoil pile #2 is completed and has been reclaimed excess for the very top surface. A new excess spoil pile #2 has been approved by the Division.

**7. Coal Mine Waste, Refuse Piles, Impoundments**

The refuse pile appeared stable. No visible hazards were observed.

**8. Noncoal Waste**

The mine site was free of noncoal waste materials.
