

2. Signs and Markers

The mine identification sign was observed at the entrance into the mine permit area. The sign is in compliance with the coal rules.

4.a Hydrologic Balance: Diversions

A large rock was observed along side of the old haul road diversion. The rock needs to be pulled back up the road a little . It has been placed there to protect a culvert inlet. Arrangements were mad during the inspection to have this work accomplished.

7. Coal Mine Waste, Refuse Piles, Impoundments

A smoker was observed on an excavated pile of refuse on the Eastern side of the mine site. Savage was notified and arrangements were made to work the excavated refuse pile to extinguish the smoker.

8. Noncoal Waste

The mine site was free on noncoal waste items.
