2. Signs and Markers

The mine identification sign is posted on a power pole at the entrance into the mine permit area. The sign was observed upon entrance into the mine permit area and was found to be in compliance with the Utah R645 Coal Rules.

4.a Hydrologic Balance: Diversions

Some tumble weeds were observed in the diversions throughout the mine site. At the present time the tumble weeds do not present a problem, but could potentially allow sediment to build at culvert inlets. The tumble weeds will be removed.

6. Disposal of Excess Spoil, Fills, Benches

Excess spoil is actively being placed in excess spoil pile phase two. The material is end dumped and then compacted.

7. Coal Mine Waste, Refuse Piles, Impoundments

The refuse pile appeared stable during the inspection. No visible hazards were observed.

8. Noncoal Waste

The mine site was free of noncoal waste items.
