

2. Signs and Markers

Checked the mine identification sign upon entrance into the mining permit area. The signs is posted on a power pole at the entrance and it contains all of the required information.

4.a Hydrologic Balance: Diversions

Diversions were open and functional.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

Sediment ponds have water in them from recent storm events.

7. Coal Mine Waste, Refuse Piles, Impoundments

Smokers were visible on the east side of the permit area. The area has been opened up allowing oxygen to infiltrate combined with the recent moisture.

The smoker's need to be extinguished. Personnel were notified to handle the problem.

8. Noncoal Waste

Mine site is free of noncoal waste items.
