**6. Disposal of Excess Spoil, Fills, Benches**

Excess spoil pile #2, Phase 2 is currently receiving material.

**7. Coal Mine Waste, Refuse Piles, Impoundments**

The refuse pile is being actively mined as a fuel source for the power plant. The pile is stable. Smokers were observed at several locations on the refuse pile. Savage was notified of the areas and arrangements were made to extinguish the smokers.
