2. Signs and Markers

The mine identification sign is posted at the entrance into the mining permit area. The sign is mounted on a power pole. The sign contains the information required in the Utah R645 Coal Rules.

6. Disposal of Excess Spoil, Fills, Benches

Excess spoil pile #2, phase #2 is actively receiving spoil material.

7. Coal Mine Waste, Refuse Piles, Impoundments

The refuse pile appeared stable. No visible hazards were observed during the partial inspection.

Mining was taking place in the vicinity of the old west slurry cell. During the excavation of the material and the introduction of oxygen some smokers are occurring. A track hoe is present abating the smokers and loading refuse material.
