## **2. Signs and Markers**

The mine identification sign is posted on a power pole at the entrance into the mining permit area. The sign meets the requirements set forth in the Utah R645 Coal Rules.

### **4.a Hydrologic Balance: Diversions**

Tumble weeds have been deposited in front of culvert inlets and outlets. The diversions are fully functional, but the tumble weeds need to be removed to prevent sediment from lodging against them and then blocking the inlets and outlets.

## **6. Disposal of Excess Spoil, Fills, Benches**

Excess spoil pile #2 phase #2 is actively receiving waste material.

## **7. Coal Mine Waste, Refuse Piles, Impoundments**

The refuse pile is stable. No visible hazards were observed.
