2. Signs and Markers

The identification signs were inspected and contained the required information as required in the R645 Coal Rules.

3. Topsoil

The topsoil piles were inspected with no signs of wind or water erosion.

4.a Hydrologic Balance: Diversions

The diversions have been functioning as design. The culverts were open and conveying water to the sediment ponds.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

All sediment ponds had water in them but were not discharging during the inspection. The site has received much rainfall the past two weeks. No hazardous conditions were noticed. The sediment ponds appear to be stable.

7. Coal Mine Waste, Refuse Piles, Impoundments

The refuse piles were stable. These piles are not being use very much, since the permittee is receiving slurry from the Wellington Preparation Plant. No hazardous conditions were notice during the inspection.

8. Noncoal Waste

The site was clear of non-coal waste materials.
