1. Permits, Change, Transfer, Renewal, Sale

There are two permitting actions on file with the Division. The two actions are Midterm review (8/27) and Sunnyside Culvert and road (9/3).

2. Signs and Markers

The identification sign is at the main gate to the complex. It has the correct and current information as required to meet the R645 Coal Rules.

3. Topsoil

The topsoil piles were inspected with no signs of wind or water erosion. They are protected by berms.

4.a Hydrologic Balance: Diversions

I inspected the diversion and culverts throughout the property. They were open and would function in a storm event. (See Pictures)

4.b Hydrologic Balance: Sediment Ponds and Impoundments

I inspected the sediment ponds and culverts and diversion inlets. Sediment ponds were basically dry with little to no water. Inlets were open with no obstructions. No hazardous conditions were noticed

7. Coal Mine Waste, Refuse Piles, Impoundments

I inspected the refuse piles with no hazardous conditions notice during the inspection. The embankments appear to be stable.

8. Noncoal Waste

The disturb area was clear of trash and oil cans.

10. Slides and Other Damage

No slides or other damage was notice during the inspection.

16.a Roads: Construction, Maintenance, Surfacing

Roads were well maintained. They are watered to reduce any dust from the surface of the road.
