1. Permits, Change, Transfer, Renewal, Sale

The permittee has two permitting actions with the Division. These are Sunnyside Completeness Response (10/26) and Sunnyside Culvert and Roads (10/11/16).

2. Signs and Markers

The identification signs were inspected and contain the required information as required in the R645 Coal Rules.

3. Topsoil

The topsoil piles were inspected with no signs of wind or water erosion.

4.a Hydrologic Balance: Diversions

The diversions and culverts were inspected. They were open and would carry water during a storm event.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The sediment ponds were inspected by me and no hazardous conditions were notice. The embankments, inlets and outlets were stable were stable. No water was discharging during the inspection.

7. Coal Mine Waste, Refuse Piles, Impoundments

I inspected the refuse pile. No hazardous conditions were notice. The embankments appear to be stable. Some mining of the refuse was taking place during the inspection.

8. Noncoal Waste

The site was clear of non-coal waste materials such as trash and oil and grease containers.

16.b Roads: Drainage Controls

Road diversions and culverts were open and would function during as storm event.
