1. Permits, Change, Transfer, Renewal, Sale

There are no pending permitting actions with the Division at this time.

2. Signs and Markers

The identification signs were inspected and contained the required information as required by the R645 Coal Rules.

3. Topsoil

The topsoil piles were snow covered. There are no signs of wind and water erosion to the topsoil piles. The topsoil piles are stable.

4.a Hydrologic Balance: Diversions

The diversions and culverts are open with snow within them. They would function correctly when the snow begins to melt.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The sediment ponds were inspected with no hazardous conditions noticed. The sediment pond was not discharging during the inspection. The embankments were stable. Some ponds were dry and others contained water.

5. Explosives

There are no explosives on site.

6. Disposal of Excess Spoil, Fills, Benches

The permittee was grading an old spoil pile during the inspection. This pile maybe reclaimed completely by next year.

7. Coal Mine Waste, Refuse Piles, Impoundments

I inspected the refuse piles noting no hazardous conditions during the inspection. The piles appeared to be stable. The permittee is mining some of the refuse.

8. Noncoal Waste

The site was clear of non-coal waste materials such as trash and cans.

16.a Roads: Construction, Maintenance, Surfacing

The permittee has finished the first segment of a new haul road which was approved by the Division. See pictures

Roads diversions and culverts were open during the inspection.
