**1. Permits, Change, Transfer, Renewal, Sale**

There are no permitting actions with the Division at this time.

**2. Signs and Markers**

I inspected the identification sign and it meets the requirements of the R645 Coal Rules at the Sunnyside Co-Gen. See Photo

**3. Topsoil**

The topsoil piles were snow covered. It is unlikely that wind or water erosion has occurred.

**4.a Hydrologic Balance: Diversions**

The diversions were snow covered. It is possible that water was flowing underneath the snow. The temperature was in the 30's and the roads were muddy.

**4.b Hydrologic Balance: Sediment Ponds and Impoundments**

The sediment ponds were snow covered. I did not see any water discharging from the ponds. The embankments, inlets and out lets were snow covered.

**7. Coal Mine Waste, Refuse Piles, Impoundments**

The refuse piles were snow covered. I did not see any hazardous conditions. The permittee was mining/using reserve coal to run the power plant. The plateau refuse pile was closed due to snow cover.

**8. Noncoal Waste**

I did not notice any non-coal waste material on top of the snow.

**10. Slides and Other Damage**

No slides or other damage was notice during the inspection.
