1. Permits, Change, Transfer, Renewal, Sale

There are no permitting actions with the Division at this time.

2. Signs and Markers

The identification sign was inspected and it meets the requirements of the R645 Coal Rules.

3. Topsoil

I inspected the topsoil piles and I did not see any signs of wind or water erosion. The topsoil piles appear to be stable and protected by a berm. The piles are snow covered

4.a Hydrologic Balance: Diversions

All diversions and culverts were snow covered. Spring cleaning will be needed once the area is dry out.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

Sediment ponds were snow covered. There was water within the ponds, but no water discharging was occurring.

7. Coal Mine Waste, Refuse Piles, Impoundments

The refuse pile was snow covered. It was not being mine due to muddy /wet conditions. I did not see any hazardous conditions.

8. Noncoal Waste

I did not see any non-coal waste material on the ground.

16.a Roads: Construction, Maintenance, Surfacing

Roads were muddy.

16.b Roads: Drainage Controls

Diversions and culverts were snow covered. Spring cleaning will be needed.
