Re: Reclamation Bond Requirements, Cyprus Plateau Mining Corporation, Blackhawk Site
Exploration Project, CEP/007/038, Folder #3, Carbon County, Utah

In light of recent activity and additional disturbance at the Blackhawk Exploration Site, the Division has reviewed the Bonding requirements for that project. The initial meetings between the Division and Cyprus Plateau discussed a reclamation bond requirement for areas disturbed during the exploration which are not on BLM administered ground. DOGM understands that the BLM holds a bond for reclamation of their lands.

The exploration plan currently calls for approximately 3.5 acres of disturbance, which includes opening 2 portals in the Willow Creek area. The Division requires a reclamation bond in the amount of \$50,000 to cover the cost of resealing the portals, removing structures, disposing of excess spoil, regrading and soil placement, and reseeded the area. This would be returned at the conclusion of the project, based on the successful performance of reclamation.

Please submit a reclamation bond in the amount of \$50,000 to this office within 20 days of your receipt of this letter. If you have any questions, please call me or Daron Haddock at 538-5340.




