The diversions throughout the property were spot-checked and some diversions contained some sage brush within them. The ditches were functioning even with brush in the ditches. Next month a complete inspection of ditches will take place.

4C. OTHER SEDIMENT CONTROL MEASURES -

Several silt fences throughout the property were spot-checked and comply with the R645 regulations. The alternate sediment control areas which were seen were performing as designed.
