The silt fences were spot-checked and were functioning as designed. These areas will be included in the new Willow Creek Mining and Reclamation Plan which will be approved in the near future.

13. REVEGETATION -

The majority of the site has been seeded in the fall of 1995. The seedlings in some areas have started to break through the ground.
