

Dear Ms. Grubaugh-Littig:

The enclosed permit modification is being performed to update the Willow Creek Mine permit to as-built status. The updated information documents the field changes made during construction. The original disturbed area in approved plan was reduced by 0.97 acres during construction. However, with subsequent permit modifications, e.g. clean coal stockpile expansion, degassification wells, and Barn Canyon Shaft, the overall acreage has increased; these increases have been or will be authorized under separate permit modification applications.

The new Willow Creek Mine facilities originally permitted were modified to more efficiently operate the mine and to reduce the overall disturbance area. The portal area in Willow Creek Canyon was reduced in size by relocating the water tanks closer to the portals and by not constructing the additional access road and bridge. Additionally, some previously existing facilities at the Preparation Plant and Crandall Canyon were removed from the site completely or relocated to another area of the mine.

It is my understanding, from Mr. Ben Grimes, that the modification of the site construction and facilities was discussed with Division management prior to construction. At that time, Cyprus indicated to the Division that there was a strong possibility that the facilities would be revised during construction and the disturbed area would be reduced. The Division management indicated that as long as the area was reduced, no implication to the permit would likely be made.

This submittal includes revisions to text, tables, maps, exhibits, and figures as identified on the C2 forms. The reclamation bond has also been revised to reflect the facilities and site accordingly.

Revisions in this submittal have been made in the text previously submitted for other recent permit change applications. These change applications include: degassification wells 97-30-2A-DG, 97-30-5-DG, Barn Canyon Shaft site, degassification wells 98-25-5-DG, 98-30-8-DG, 98-30-9-DG, 99-30-10-DG, and 99-30-11-DG. The revised text, tables, maps, exhibits, and figures included in those submittals are included in this submittal.


