2. Signs and Markers

Signs with the required information were posted at the entrances to the reclaimed areas.

3. Topsoil

The topsoil distributed at the reclaimed loadout area was stable and showed no signs of erosion or off site sediment transport.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The sediment pond was noted as being dry at the time of this inspection.

11. Contemporaneous Reclamation

Reclamation at the loadout area included shaping, roughening, topsoil distribution, and seeding. The vegetation is well established and the area is stable.
