The diversions were spot-checked and found to be open. There were no signs of water erosion.

4.c Hydrologic Balance: Other Sediment Control Measures

There were no signs of water erosion. The pocking of the ground holds the water and reduces the possibility of rills to develop.

4.d Hydrologic Balance: Water Monitoring

The permittee has submitted the third quarter water data to the Division.

7. Coal Mine Waste, Refuse Piles, Impoundments

The refuse pile was reclaimed. I did not see any hazardous conditions during the inspection.

The site is completely backfilled and graded.
